1 MICHELE SAUCEDO: Good afternoon. I'm talking 2 about the 20, 71, and 69A. 3 The 71 and 69A, the buses that go by hospitals, 4 should not be discontinued. This is my opinion. 5 Now, the housing authority is located on 6 Mission Street extension, bus number 20. A bunch of us 7 are on housing and social security. Please do not take away our buses. This is our only way of transportation. 8 Please ride our buses. 9 10 Thank you. 11 Also, the 69A goes to Watsonville. My neurologist could jeopardize my life. 12 13 Thank you. 14 Any bus that goes by the hospital should not be 15 discontinued, and 69A is one of them. But it goes to my 16 doctor. I have to take the 69W to go Watsonville, where 17 my neurologist is. 18 Now, from what the bus driver was telling me, 19 they got some funding this morning. It just came in. 20 They're not going to cut it out, they're just going to cut it down. So I can work around that. 21 22 I'm not going to get behind the wheel of a car 23 when I have seizures. So I'm not going to do that. 24 Some -- a lot of these board members that make 25 six figures a year, sometimes they don't realize what

1 little people go through. And if they would ride the buses and listen the them, because the bus drivers hear 2 3 enough of it, I'm sure they might learn something. But 4 they don't care. That's the feeling I'm getting. They 5 don't care. 6 And I feel sorry for the 30 or 40 bus drivers 7 in jeopardy of losing their job. And they have 8 responsibilities like everyone else: Family, put food 9 on the table, pay rent, this and that, PG&E. You know, 10 our PG&E goes up. 11 And the thing about raising the minimum wage, 12 well, guess what? They'll probably raise the bus fare, 13 too. Well, I guess that happens. But it's sometimes 14 you just can't win for losing. 15 Maybe they can combine the 20. 16 The housing authority is a block north of that 17 going towards Frisco. It's way out there, I think, on 18 that same street where the marine lab is. I can't 19 remember the name of that street. But that's where the 20 20 goes. And the housing authority is out there. And a 21 bunch of people that are on social security are on 22 housing authority. And if the housing authority doesn't

we have to go out there. So maybe they could combine

the 20 with something else? Or with something.

1 CHRISTIE MCCULLEN: I am a faculty member of 2 Cabrillo College. And we recently passed this 3 initiative there to give them, METRO, around a fifth of 4 the money they need to close their budget loop. And 5 the -- so all these students are going to now have a 6 free bus pass, essentially. And we want to make sure 7 that the routes that serve Cabrillo are not cut and not 8 reduced as much as they are proposed to be reduced. 9 So, for instance, like the 69W is a big 10 Cabrillo one, between Watsonville and Cabrillo. And 11 they want to change the service to every 60 minutes

12 instead of every 30 minutes. And if our students -- so 13 there are several bus routes that the students coming 14 from Watsonville will be taking: 71, 91, or 69W. So if 15 there's already -- they're cutting -- proposing cuts to 16 71 in half and 91 altogether, and so that's going to 17 make more students go to the 69W. Going to make more 18 crowding on that bus. And then if students miss a bus 19 by 30 minutes, then they will miss 30 minutes of class, 20 essentially.

We're worried that our enrollment is going to go down because of this and that we're going to have a lot of students drop if they continually have problems getting to campus. So that's a big concern for us.

So that's the 69W, 71, 91 issue.

| 2 | Well, we're particularly concerned about |
| 3 | reductions of different routes creating crowding on the |
| 4 | routes that are going to Cabrillo, and then our students |
| 5 | aren't going to be able to get to campus, or get to |
| 6 | campus on time. So our enrollment will drop as a |
| 7 | result, or students wouldn't be able to get their |
| 8 | money's worth. |
| 9 | The other thing is, we feel that now that we |
| 10 | have passed an initiative and worked really hard to pass |
| 11 | an initiative on a campus that would close a fifth of |
| 12 | the budget gap for METRO, that they should consider |
| 13 | catering to students in that regard. |

ERNESTINA SALDANA: What I want to say is that I live at 951 30th Avenue, and I live -- that's between Brommer and Portola Street.

I take the 68 to go to my acupuncture sessions paid for by Medi-Cal, and I use it once a week. Generally, I have to be there by 9:00 a.m. and I get out by 11:30 or so. So METRO's proposal is limiting my ability so I can take full advantage of that benefit.

9 I go to different meetings in Watsonville and 10 in Santa Cruz, to East Santa Cruz and West Santa Cruz, 11 all the way to Fern Street. Sometimes I have to go to 12 housing authority offices because I do have an 13 affordable apartment. And I have to take the other 14 buses. I have to transfer to other buses.

So one of the problems I have is when I have to go to West Santa Cruz, if I have to transfer to another bus, generally it's the 10. And so if the hours of service will be reduced, I understand that the reduction will be -- or the bus will run every two hours or every other hour, and then the bus will be at full capacity.

21 So what will happen if the bus is already full? 22 And it's happened to me before. Will the driver ask 23 passengers to get off the bus? Or will the driver tell 24 me to wait for another bus, which may take another two 25 hours?

1 And when I go to Watsonville, I take the 69A. 2 Because from my house, it takes me straight to 3 Watsonville. It stops at the mall, and then we go 4 straight to Watsonville. That saves me a lot of time. 5 My son lives in Watsonville and he takes the 6 91X, and then the 35 so that he can get to work in 7 Scotts Valley. And with this proposal, both routes will 8 disappear. 9 So our only choice is to buy a very inexpensive 10 If you know of one, I'll appreciate it. car. 11 I go to doctor's appointments. I have to go to 12 Frederick Street to Dominican rehab. I have an 13 orthopedic doctor very close to Dominican Hospital. Ι 14 also have another physician at Palo Alto Medical 15 Foundation. I have my therapy on Frederick Street, and 16 to come to -- my orthopedist is the one that looks at my 17 wheelchair, my wrist splints, looks at everything, 18 thumb. So I have to go full circle with all the buses 19 because I cannot take just one bus. 20 The fact that they have said that ParaCruz will not be restricted or limited, that doesn't benefit me 21 22 that much. Because that -- in fact, that increases my 23 monetary expense by \$4 per trip. 24 25

1 I take 13 of the bus routes on JANE GALLAGHER: 2 a regular basis. The 54, 55, 56 routes into Seacliff 3 and Rio Del Mar area is a daily commute route for work. 4 I would like to see, if they do the route that they're 5 thinking of doing at 8:30, 1:30, and 5:30 out of the 6 Capitola Mall, if it could be 11:30 so people who work a 7 half day or can get an eight-hour shift, and a 2:30 --8 Buses leaving the Capitola Mall, one suggested 9 time is 8:30, 1:30, and 5:30 leaving the mall. If that 10 1:30 could either be changed to an 11:30 or an 11:30 11 added, it enables people who work half a day to go in for the afternoon shift in the evening. Or people who 12 13 go to appointments, to come back before 6 o'clock. 14 Primary. 15 Secondary, the 91 bus matching up with the 69, 16 the 54, 55, 56, and Cabrillo, those buses all come in 17 within two or three minutes of each other. And the 91 18 leaves or the 69 leaves or the 54 leaves without being 19 able to pick up passengers. So if they could all stay 20 and wait there, maybe three to five minutes, and 21 communicate better, it would be an easy transfer and 22 we'd have less unhappy riders. 23 Ultimately, I would like to see an extra hour 24 in the morning, maybe a 7:15 bus heading through that 25 area between Cabrillo and Watsonville on the Seacliff

| 2 | expand the routes to include more commuters to the |
| 3 | Capitola Mall and to downtown Santa Cruz routes. |
| 4 | Also, if the 55, 56, and 54, as they go |
| 5 | northbound out of the end of their route, if they could |
| 6 | take Soquel Drive instead of Highway 1, would increase |
| 7 | ridership to the grocery stores, to the restaurants, to |
| 8 | the other buildings, to the new Aptos Village complex, |
| 9 | and to the community center at the corner of across |
| 10 | from Safeway, where the Aptos Blue residential |
| 11 | neighborhood has just been built for low income housing. |
